## **About the Position:** Community & Economic Development Director

#### The Role

The City seeks a highly motivated and innovative Community and Economic Development Director to lead the organization's efforts in building strong partnerships and creating sustainable solutions for Pasco's communities. As the CED Director, you will be responsible for developing and implementing strategies that promote social and economic growth.

In this role, you will oversee development review, downtown revitalization, inspection services, planning services, and development services engineering. You'll have the opportunity and responsibility to shape a comprehensive economic development image of the City through short and long-term marketing and recruitment efforts and provide leadership to incorporate 50,000 additional residents in the next 20 years!

The new CED Director will:

- Develop and implement comprehensive community development plans that align with the goals of the City Council.
- Foster a culture of innovation and creativity, encouraging new ideas and approaches to community development.
- Identify community needs and develop programs and initiatives to address those needs.
- Provide technical support and policy advice to the City Manager, City Council, and staff.
- Develop and manage department budgets, ensuring efficient use of resources.
- Cultivate and maintain partnerships with community and development organizations, local government officials, and other stakeholders to promote development initiatives.
- Represent the organization at community events and public forums to promote community development initiatives.
  - Provide excellent customer service to residents by being accessible, responsive, and attentive to the needs of the community.

### The Ideal Candidate

The City of Pasco seeks a forward-thinking leader to lead the CED department. The ideal candidate will be customer-service focused, open-minded, and strategic. They will be attentive, ensuring staff accountability while leading the department's success. The candidate must be personable and utilize high levels of collaboration, patience, and persistence in providing services and working with City staff, outside agencies, and the public.

The candidate will have extensive knowledge of regulations and techniques of community planning and economic development as well as management techniques, supervisory principles, budget preparation, expenditure control, and record keeping.

Additionally, the ideal candidate will have the ability to establish and maintain effective working relationships with City, county, state, and federal officials, local stakeholders, and the general public. The individual will use sound judgment to conduct effective negotiations and represent the City and department in meetings with governmental agencies as well as various businesses and professional, regulatory, and legislative organizations.

#### **Qualification Requirements**

**Experience:** Six years of progressively responsible experience in land use planning and comprehensive plan development; three years of senior managerial experience

**Education:** Bachelor's degree in urban planning, municipal planning, community development, public administration or related field; masters preferred

#### **Certification:**

- Possession of a valid Washington driver's license upon appointment. This position requires frequent driving for City business
- American Institute of Certified Planners designation preferred



## **Compensation & Benefits**

The annual salary range is \$124,800 - \$174,400. *Salary survey is planned in approximately 6 months.* 

- Medical Insurance: Employee and all eligible dependents covered for \$153.70/month. Low deductible, \$200 for individual, \$600 for family.
- Dental Insurance: Employee and all eligible dependents covered for \$11.59/month.
- **Vision Insurance**: Employee and all eligible dependents covered for \$6.54/month.
- **Life Insurance:** \$100,000 basic life insurance provided by the City.
- **PERS Retirement Plan:** The City of Pasco participates in the Department of Retirement Systems that provides two plan options for employees:
  - **PERS II:** Employee contribution rate: 6.36%. Employer contribution rate: 10.39%
  - **PERS III:** Employee contribution rate: employee choice. Employer contribution rate: 10.39%

- Mission Square Deferred Compensation Plan: Automatic employer pre-tax contribution of 3%. Employee contribution options include pre-tax and Roth.
- **Holidays:** The City observes 11 per year (10 scheduled, 1 "floating").
- Vacation Leave: 24 days per year. Vacation leave is available for use as it is accrued.
- Sick Leave: 12 days per year. Sick leave is available for use as it is accrued.
- Other benefits include: Auto allowance, gym membership, comprehensive employee assistance program, short-term and long-term disability insurance, and 2% HRA VEBA salary deferral.
