A City staff of 140 FTE are responsible for public safety, public works, land use and municipal court services covering the Island's almost 28 square miles.

The City Attorney provides comprehensive legal services to the City. As the City Attorney, you will be a vital member of the City's leadership



team, supporting the decision-making of both the City Council and City administration. You will report to the City Manager and will have the support of a Deputy City Attorney (a position that is currently open and for which you will help select a candidate to fill).
