# Five-Year Captial Improvement Program (Fiscal Years 2022-2027)

Menifee understands how circulation plays a vital role in the quality of life of our residents. Menifee's Capital Improvement Program is a commitment to Park, Infrastructure, and Circulation Improvement projects over the next 5 years, aimed at the improved quality of life for residents, and making it easier to do business in Menifee.

#### **New Commercial Construction**

A strong economy and regional growth, along with Menifee's continued population growth, have strengthened demand in Menifee for more commercial and retail spaces. That demand is being met with more than 235 project applications that are working through the City's approval and permitting process this year alone, with over 1.8 million square feet of commercial space currently under construction or in plan check.



# ABOUT THE FINANCE DEPARTMENT

The City of Menifee Finance Department oversees an operating budget of \$90 million and a citywide budget and fiduciary funds totaling over \$137 million. Current major projects include the implementation of the Munis Enterprise Resource Planning System.

Menifee's award-winning Finance Department is a driven, creative team with a vision to uphold Menifee's standards of NEW, BETTER and BEST. Our team members collaborate across departments to remain nimble and boldly channel the City's entrepreneurial spirit as our community grows. The team's technical skills produce excellent results in managing the City's financial status.

### **ABOUT THE POSITION – CHIEF FINANCIAL OFFICER**

#### **The Role**

Menifee's CFO will be a mentor and leader in the department and will work to develop creative, effective solutions for the City. You'll work closely with the City Manager and City Executive Team to effectively distribute resources with a long-term vision of growth and clearly share plans with the City.

As CFO, you will strategically plan, direct and manage the activities and operations of the Finance Department, including around \$500 million in capital projects in a growing community. You'll use your experience to develop and administer policies regarding the investment of City funds, develop the City budget, and oversee the verification of financial documents.

The CFO will also serve as the City Treasurer, managing a financial portfolio of nearly \$190 million.

#### **The Ideal Candidate**

While your knowledge in finance and accounting is important, we are also looking for an individual with an entrepreneurial mindset, ready to think outside the box and provide creative solutions. You'll be a growthminded individual ready to make decisions from a big-picture perspective. You'll be an innovative, dynamic, and highly effective leader ready to manage the financial affairs of Menifee.

### **COMPENSATION AND BENEFITS**

The annual salary range is \$179,805-\$230,729 as of July 1, 2023.

- Cafeteria Plan: The City provides a monthly allowance up to \$1,850 for employees and eligible dependents to use towards medical, dental, vision, voluntary life insurance, disability insurance and flexible spending accounts.
  Continued Education: 5% education incentive for a master's degree or professional certification in alignment with the position, which is above the minimum job requirement.
  Deferred Compensation Plan: 5% of base salary
- **Medical Insurance:** The City offers a variety of HMO and PPO health plans, administered through CalPERS.
- CalPERS.
  Dental and Vision Insurance: Dental HMO or PPO and Vision Insurance plans available.
  Vacation Leave: 120 hours for the first three years with the City with increases up to 200 hours after five years.
- Life Insurance: City-paid \$200,000.
- **Retirement:** The City offers a defined benefit retirement plan through CalPERS with a vesting period of five years. Employees contribute:
  - Classic Members are 2.7% at 55 years old
  - PEPRA are 2% at 62 years old

A Finance Director manages money, a CFO figures out how to strategically make money a tool to help the City achieve its goals. How are we going to keep Menifee a growing economy? How will we provide resources for a growing community?
