

The Public Works Department

Santa Paula's Public Works Department is responsible for the essential systems that keep the city functioning every day. From clean drinking water to safe streets and stormwater management, the department's work touches every resident and business in the community.

With a team of roughly 25 employees, Public Works oversees street maintenance, fleet services, water operations and stormwater compliance, while coordinating wastewater efforts with the Ventura County Wastewater District. Engineering services are primarily contracted out, but the Assistant Public Works Director/City Engineer will provide in-house expertise, supervising the Streets Division and Permit Technician, managing the Capital Improvement Program (CIP) and reviewing and approving public works plans and standards.

The Public Works Department plays a critical role in keeping Santa Paula running:



Capital Improvement Program (CIP) Planning and Delivery

Developing, managing and updating the City's CIP to ensure timely delivery of road, water and wastewater projects that keep pace with growth.



Streets and Traffic Operations

Overseeing street maintenance, striping, signals and storm drain systems – with every street scheduled for improvement over the next five years.



Water and Wastewater Coordination

Supervising potable water operations, coordinating with the Ventura County Wastewater District and aligning underground utility upgrades with roadwork.



Engineering Review and Standards

Serving as City Engineer for subdivision map review, public right-of-way improvements, plan approvals and engineering standards.



Contract and Project Oversight

Managing public works construction contracts, reviewing work for compliance and keeping projects on time and within budget.



Team Leadership and Development

Reporting to the Public Works Director, this role supervises the Streets Division and Permit Technician, supporting a 25+ member department and helping build a collaborative, high-performing team culture.

As Santa Paula's next Assistant Public Works Director/City Engineer, you'll play a hands-on leadership role guiding the City's infrastructure projects and supervising key public works functions. Working closely with the Public Works Director, you'll oversee the Streets Division and ensure that the City's Capital Improvement Program delivers on its promise to transform the community.

This is a rare opportunity to lead major road and utility improvements, streamline processes and make a visible impact on how residents experience their city every day. You'll be joining a supportive, high-performing team with a clear mission: keep Santa Paula's infrastructure strong, reliable and ready for the future.

Reporting to the Public Works Director, you will:

- Serve as City Engineer, reviewing subdivision maps, approving public works plans and establishing engineering standards.
- Supervise the Streets Division and Permit Technician, ensuring high-quality maintenance and timely project delivery.
- Provide technical assistance and oversight to the department's operations, including Administration and Engineering, Fleet Maintenance, Streets Maintenance, Water and Wastewater.
- Plan, manage and update the City's Capital Improvement Program (CIP).
- Oversee public works construction contracts and verify compliance with approved plans and specifications.
- Coordinate with the Water Division and Ventura Regional Sanitation District to align underground utility upgrades with road work.
- Provide input on departmental budgets, monitor expenditures and support efficient use of resources.
- Collaborate across City departments to keep infrastructure projects on schedule and aligned with City priorities.
- Respond to resident concerns and resolve issues with a focus on customer service and community trust.

This role calls for a seasoned municipal civil engineer who combines strong technical knowledge with hands-on leadership and a commitment to getting projects delivered. The Assistant Public Works Director/City Engineer must be able to balance field operations with administrative oversight, coordinate across divisions and keep infrastructure projects aligned with community priorities.

Experience supervising office and field staff is highly desirable. Eight to twelve years of public sector experience; municipal civil engineering preferred.


