Located on the breathtaking North Coast of California, the agency is a highly successful, award-winning Community Choice Aggregator (CCA) dedicated to reducing energy demand, increasing efficiency and advancing local, renewable energy resources. RCEA manages an expansive portfolio of clean energy initiatives, including electrification and cutting-edge resiliency infrastructure designed to reduce greenhouse gas emissions and promote local energy sustainability.

RCEA proudly owns and operates its own microgrid, known as the Redwood Coast Airport Microgrid, providing grid reliability during severe weather, earthquakes and broader power outages. Additionally, the agency serves as the portfolio administrator for an innovative 17-county Regional Energy Network. RCEA is also at the forefront of regional advocacy and outreach for offshore wind development.

ABOUT THE POSITION

The General Counsel Role

Appointed by the Board of Directors, the General Counsel receives administrative direction from the Executive Director and is responsible for planning, organizing and managing all of the legal services and activities of the agency.

An essential component of this role involves collaborating closely with the Executive Director who manages numerous high-priority initiatives simultaneously and maintains an ambitious vision for the future of the organization. In this position, you will serve as a legal partner who ensures regulatory compliance and risk mitigation while actively helping to achieve strategic goals.

IN THIS POSITION, THE GENERAL COUNSEL WILL:

- Provide primary legal advice and guidance to the Executive Director, Board of Directors and staff on public agency compliance as well as federal, state and local laws. Public agency compliance includes but is not limited to Brown Act, California Public Records Act and Conflict of Interest Laws.
- Oversee, draft and negotiate a wide array of contracts, agreements, power solicitations and procurement templates.
- Attend Board and committee meetings while reviewing agendas, staff reports and structural governance materials.
- Direct legal strategies for risk mitigation, internal policies and potential public litigation.
- Participate directly in director-level meetings to align legal considerations with operational realities and upcoming initiatives.
- Serve as an advocate and liaison with regulatory bodies and state associations like CalCCA.
- Develop, implement and maintain standardized contract templates, legal provisions and standard terms and conditions to establish operational consistency across all departments.

GENERAL COUNSEL COMPENSATION AND BENEFITS

- **WORK SCHEDULE:** Employees enjoy a 34-hour standard workweek consisting of four 8.5-hour days.
- **MEDICAL BENEFITS:** RCEA provides comprehensive employer-paid medical, dental and vision insurance. The agency pays 100 percent of the monthly premium for single coverage and maintains a 50 percent premium share for two-party and family dependents.
- **HOLIDAYS:** Employees receive 12 annual paid holidays.
- **RETIREMENT PLANS:** The agency provides a \$4,000 annual employer contribution to a 401(a) plan along with an employee matching structure of up to 7%. Access to a 457(b) deferred compensation plan is also provided for supplemental contributions.
- **PAID TIME OFF:** Vacation tracking starts at 12 days per year and paid sick leave accrues at seven hours per month.
- **ADDITIONAL BENEFITS:** The benefits package includes an employer-sponsored Employee Assistance Program alongside a \$25,000 life insurance policy.
